
Framework Agreement for TD SYNNEX Customer Relations

TD SYNNEX is offering you as a customer the opportunity to access its (Extranet) websites. These websites enable you to do business with TD SYNNEX electronically — 24 hours a day, 7 days a week.

We will provide you with login information to access the online e-business applications. You will receive this information after we have received this completed and signed form from you.

Using InTouch, the TD SYNNEX online ordering system, you will be able to access TD SYNNEX article and inventory information straight away and place orders online quickly and easily.

In addition to the applicable general terms and conditions including the return policy, the following is agreed:

Article 1 — Financial conditions

To become a customer of TD SYNNEX, your company's statutes must clearly state that the main activity of your business is the resale of IT, telecommunications or consumer electronics products to more than one end customer. In addition, the expected annual turnover should be at least \leq 15,000 (excl VAT).

TD SYNNEX has no obligation to accept a new customer. If no turnover has been achieved at TD SYNNEX after six months, TD SYNNEX may terminate any agreement and delete your data from our database.

The first two orders are always delivered upon receipt of pre-payment/online payment when entering the order in InTouch. After these two orders, your company can apply for a credit limit. To do this, please contact customer accounts by email at <u>creditcontrol.be@tdsynnex.com</u> for customers in Belux and <u>creditcontrol.nl@tdsynnex.com</u> for customers in the Netherlands. TD SYNNEX can—without being obligated to do so—grant your company a credit limit; this limit can be amended or withdrawn unilaterally.

All transport costs for cross-border deliveries are always borne by the customer and are paid in advance. In these cases, the minimum amount for the first order is €10,000 (excl VAT). TD SYNNEX will organize transport; the rates depend on the location, weight and requested delivery time. Your internal sales contact can give you a summary of the delivery rates.

Article 2 — Use of the TD SYNNEX website

The customer uses the TD SYNNEX websites at their own expense and risk. TD SYNNEX aims to make the TD SYNNEX website available 24 hours a day, 7 days a week; however, it does not provide the customer with any guarantee in this respect and therefore excludes any liability for damages and/or costs arising from or in connection with the non-availability of the TD SYNNEX website.

The customer must provide suitable hardware, software or other necessary items or licenses to access and use the TD websites.

The TD SYNNEX websites, whether by means of hyperlinks or otherwise, refer to information provided by third parties. Such information has not been further evaluated by TD SYNNEX for reasonableness, accuracy, completeness or topicality. TD SYNNEX expressly rejects any liability in this respect.

The information provided is not intended as a substitute for expert advice. If you use the information provided without verification or further advice, you do so at your own expense and risk.

TD SYNNEX, or the rights holder, respectively, retains all rights (including copyrights, trademark rights, patents) in relation to information presented on the TD SYNNEX websites (including texts, graphics and logos). You will not obtain any form of license in relation to this information except as strictly necessary for online viewing of the TD SYNNEX websites. In particular, it is not permitted to copy, reproduce or in any way make available to any third party the contents of the TD SYNNEX websites without the express written permission of TD SYNNEX.

The exclusions and limitations of liability also extend to the benefit of directors and employees of TD SYNNEX and its group companies.

Article 3 — Appointment of the Administrator

The customer appoints an administrator, hereinafter referred to as 'Administrator.' The Administrator is designated by the customer as a contact person for TD SYNNEX and is responsible for the use of the TD SYNNEX websites in the name of and on behalf of the customer. The contact details for the Administrator are included in this Agreement.

The customer may authorize the Administrator to place orders with TD SYNNEX in the customer's name and/or to communicate different delivery addresses to TD SYNNEX.

The customer should immediately notify TD SYNNEX of the date as of when another Administrator is appointed. In this case, TD SYNNEX will assign the customer new login codes as of that date. The old login codes will expire on the same date.

Initials for approval :

The Administrator controls the use of the TD SYNNEX websites on behalf of the customer. The Administrator is responsible, among other things, for:

 Designating the persons who will have access to the TD SYNNEX websites within the customer's company (hereinafter referred to as 'the Users')

- Giving personal login codes to each of the Users
- Cancellation of the Users
- Determining the address to which the products ordered through the TD SYNNEX websites are delivered
- Determining authorizations of the Users
- Canceling certain authorizations of the Users

The Administrator can modify the above information independently. The customer shall have full and exclusive responsibility for the appointment of the Administrator, the supervision of the Administrator, as well as for all acts and omissions of the Administrator, including in any event the exercise of the powers set out in this Agreement.

TD SYNNEX shall in no event be liable for any damage or costs (allegedly) incurred by the customer, their customers or other third parties due to acts or omissions of the Administrator, the Users and/or any person connected to their company in any way. The customer indemnifies TD SYNNEX against any possible damages that TD SYNNEX would have to reimburse and which have been incurred by the Administrator, the Users, and/or any person connected in any way to the customer's business.

Article 4 — Assigning login codes

After the conclusion of the Agreement, TD SYNNEX assigns the customer personal login codes (hereinafter referred to as 'the Login Codes'). The Login Codes are shared with the Administrator by email. The risk that the email containing the Login Codes is not received by the Administrator, is received or intercepted by a third party, or that a third party acquires knowledge of the Login Codes and the Login Codes are misused as a result is passed to the customer.

The Login Codes have three functions:

- The Login Codes grant access to the TD SYNNEX websites
- The Login Codes identify the Administrator and/or a user at the customer's premises
- The Login Codes demonstrate the customer's consent for the orders placed by them or on their behalf

TD SYNNEX assigns the customer one unique set of Login Codes and will do all that is reasonably possible to ensure the confidentiality of the Login Codes.

The customer shall have full responsibility for the management and use of the Login Codes by the Administrator, by the Users or by third parties. TD SYNNEX is not liable for misuse of the Login Codes and the resulting damage and costs, except in the case of intent or gross negligence on the part of TD SYNNEX or its managerial staff.

The Administrator can change the assigned Login Codes independently. The customer is obligated to delete the Login Codes each time the Administrator cancels a user.

TD SYNNEX shall in no event be liable for errors and/or misuse resulting from the changes mentioned in this article.

Article 5 — Different delivery addresses

Upon obtaining their login details, the customer will not be granted the right by default to send shipments to a delivery address other than the customer's delivery addresses known to TD SYNNEX.

If the customer deems it desirable, TD SYNNEX can activate the functionality of shipment to delivery addresses not known to TD SYNNEX. The rights will be assigned to the Administrators as indicated to TD SYNNEX.

The Administrator is responsible for granting these rights to other users at the customer's premises.

If the Administrator or a user does not use the functionality for dispatching orders to different addresses for a period of 30 (thirty) days, TD SYNNEX has the right to (temporarily) disable this functionality.

TD SYNNEX shall not be liable for any costs and/or damage in the event of accepted deliveries at an address incorrectly specified by or on behalf of the customer.

Article 6 — Orders

Using the Login Codes, the customer can access, among other things, the TD SYNNEX websites and the TD SYNNEX product and inventory records. The customer can order both products that are in stock and products that are temporarily out of stock.

The correctness of an electronically placed order will not be disputed by the customer. The customer shall be bound at all times by electronic orders placed by the Administrator or by users via the TD SYNNEX websites.

TD SYNNEX takes reasonable care to ensure that the information on the TD SYNNEX websites is accurate, complete and up-to-date. However, TD SYNNEX is under no circumstances bound by incorrect information on the TD SYNNEX websites and is not liable for any damages or costs incurred by the customer relating to or resulting from incorrect information on the TD SYNNEX websites.

In the event of doubt as to the accuracy of the information provided on the TD SYNNEX websites, including the price, the customer must verify this with TD SYNNEX.

Article 7 — Brands

The brands, logos and third-party data (data from a content provider) used and/or displayed on the TD SYNNEX website may not be used by the customer in any way without the prior written consent of the rights holder of such brands and/or data.
